### CITIZENS FOR PRISON REFORM

Citizens for Prison Reform (CPR) is a grass-roots, family-led initiative that engages, educates, and empowers those affected by crime and punishment to advance their constitutional, civil and human rights. It is an organization of prisoners' loved ones and concerned It assists prisoners' families citizens. and friends in navigating the corrections system. It was started in 2011 by family members of a 15 year old boy who was sentenced to prison. CPR holds monthly educational and support meetings in Lansing on the third Saturday of each month. It puts on an annual Legislative Education Day which brings together family members, friends, advocates, and Michigan Legislators. It's operated entirely by volunteers and is currently funded by private donations and small grants. CPR became a nonprofit organization with 501(c)3 status in September of 2012. All contributions are tax deductible.



#### SOLITARY CONFINEMENT CELL

CPR has created a mock-up of a solitary confinement cell. It displays the cell in the Capitol on Legislative Education Day and at other community events. The cell shows the limited amount of space and the isolation a person experiences when placed in segregation.

### **2016 ANNUAL MEETING**

CPR held its Annual Meeting in the evening with a dinner and program at the Unitarian Universalist Church of Greater Lansing. Sixty-four people attended. CPR displayed its mock segregation cell. Judge Deborah Thomas of the Wayne County Circuit Court spoke about her efforts to incorporate restorative justice principles in her criminal docket. Greta Mchaney-Trice, Executive Director of Resolution Services Center of Central Michigan, spoke about the Center's Restorative Justice School Program and its other services.



At the October 2016 Annual Meeting Richard Rienstra, Rita Kerwin, and Sherrie Guess were reelected to threeyear terms as Board Members. New Board Member Lisa Biggs was also elected to a three year term. Sandra Girard was reelected as President. Pete Letkemann as VicePresident. ### **MONTHLY PROGRAMS 2016-17**

Thanks to all the people who gave their time to present information and ideas at CPR's Monthly Meetings.

October 15, 2016 We started out the year with a great program, "Do We Need Restorative Justice?" Judge Deborah Thomas of the Wayne County Circuit Court spoke about her efforts to incorporate restorative justice principles in her criminal docket.

Greta Mchaney-Trice, Executive Director of Resolution Services Center of Central Michigan, spoke about the Center's Restorative Justice School Program. She also discussed the Center's other services to groups and individuals, including families and youth. The Center teaches how to resolve conflict through a variety of methods that include mediation, facilitation, restorative practices, and training. November 19, 2016 The Center for Michigan conducted a Town-Hall style meeting with CPR attendees. It is a 501(c)(3) nonprofit, nonpartisan organization. The Center's work can be described in only three verbs - engage, inform and achieve - which work together to make up a dynamic model of social and political change. The Center asked the Michigan public about their trust in state government. During 2016, The Center conducted such meetings throughout the state. The resulting report, "Fractured Trust: Lost faith in state government and how to restore it," was published March 21, 2017 and can be downloaded

December 10, 2016 Sandra Girard presented information on the work of Michigan Collaboration to End Mass Incarceration (MI-CEMI). She also shared information on Nation Outside, a new organization to empower and give a voice to returning citizens in our communities

January 21, 2017 CPR screened the film, Bridges," "Burning а 35 minute documentary about the arson of an historic wooden covered bridge in Bucks County, Pennsylvania. It covers the eventual apprehension of six local, college age men who set the fire. The focus of the video is made up of footage of the restorative conference conducted bγ the International Institute for Restorative Practices. It concludes with television news footage after the sentencing.

February 18, 2017 Pete Letkemann, Lois Pullano and Allison Cox, Family Advisory Board Members, presented information on the issues it has been working to address with the MDOC at their quarterly meetings. Attendees were invited to give input to be taken back to the quarterly meetings.

### March 18, 2017 Kyle Kaminski

Legislative Liaison, Michigan Department of Corrections shared the Department's goals of increased programming, family inclusion, support and positive steps towards rehabilitation within MDOC. He discussed the Department's work with the



Family Advisory Board, a part of Citizens for Prison Reform's work. He answered numerous questions from the audience.

**April 22, 2017** Training on meeting with Legislators was provided. Attendees worked on and discussed the 2017 CPR Priorities for the 6<sup>th</sup> Annual Legislative Education Day.

May 11, 2017 CPR's Sixth Annual Legislative Education Day. Legislative Co-Sponsors Rep. Martin Howyrlak, Rep. Dave Pagel, and Rep. Stephanie **Chang** gave welcoming remarks. David LaGrand and MDOC Director Heidi Washington were the keynote speakers. Prof. Paul Draus, University of Michigan - Dearborn, reported on the Restorative Justice Project at Macomb Correctional Facility and Prof. Aaron T. Kinzel. University of Michigan Dearborn, explained Post-Incarceration Syndrome.

July 15, 2107 Prof. Aaron Kinzel is passionate about Restorative Justice and its impact. Aaron talked about how he used Restorative Justice when he was incarcerated and conducted a restorative justice exercise.

August 19, 2017 Pete Letkemann, CPR Vice-President, and Chairperson of the Family Advisory Board screened "Faces of Incarceration," a documentary about prison families. Pete appears in the film

produced by the International Prisoner Family Conference.

September 16, 2017 Aaron Suganuma, MSW, is the Coordinator of Nation Outside, the Director of Brighter Way (a mentoring program for returning citizens), and a Substance Abuse Counselor. He talked about his re-entry work. Formerly incarcerated himself, Aaron discussed how families can best support a returning loved one.

### 2016-17 CPR PRIORITIES

Each year CPR focuses on a few issues that are important to prisoners' families. The 2016-17 priorities focus on increasing Family Connections, Healing and Support:

## Support a Family Advisory Board Bill Rep. Stephanie Chang

- A pilot Family Advisory Board currently works with MDOC Administration to:
  - Suggest revisions to MDOC's Family Information Packet;
  - Provide ways to improve family visitation statewide:
  - Present concerns affecting families with incarcerated loved ones; and
  - Address barriers to families supporting their loved ones.

# Provide Orientation for Family Members of Michigan Prisoners

- Families need to know how to navigate the prison system
- Families need to know policies and procedures on visitation, phone calls,

- programming and parole from the beginning of the sentence
- CPR wants to work with Legislators and MDOC to make this happen Promote family reunification through policies and programs
- Help resolve issues between families and prisoners to increase success
- Provide restorative justice programs to families and their loved ones
- Eliminate visitor restrictions for substance abuse misconducts
   Protect corrections reforms that reduce prison population and recidivism
- Corrections Budget We need real reforms that maintain reductions in prison population and reduce recidivism - not just cutting prison funding today.
- Reductions to prison operating budgets cuts staffing and programs at all facilities.
- Understaffed facilities are unsafe for staff and prisoners.
- Inadequate staffing negatively impacts visiting which hurts families and children.

### **FAMILY PARTICIPATION PROGRAM**


